Ms. Martha Steinbach of 8 Wanamaker Avenue would like to know the status of the Train Station maintenance.

Mr. Stephen Wilson of 10 Judith Ann Court is against the proposed Cannabis Store in Mahwah. He is concerned the crime rate will increase due to the Cannabis business and customers. He is also concerned with the location near schools and students. Mr. Wilson would like the Council to vote No on the Cannabis Ordinance.

Mr. Stephen Cerullo of 87 Deerfield Terrace is against the Retail Cannabis Store within School Zones and within the Township. He stated there are many hazards associated with Cannabis entering Mahwah and is concerned about the safety of the residents.

Mr. Jim Cancelosi of 148 Island Road is opposed to the Retail Cannabis Store being built within a high traffic area, near Schools and Places of Worship. He is concerned about the safety and welfare of the Township residents and neighboring towns if the Mahwah continues with the Cannabis Ordinance.

Mr. Kenneth Cerullo of 9 Doremus Road stated the State made Cannabis legal and Municipalities have a right to opt out of the law. He would like the Township Council to vote No to the Cannabis Ordinance. Mr. Cerullo stated traffic, safety, crime and health are major concerns surrounding a Cannabis Store entering the Township.

Mr. Sal Sprofera of 29 Jahn Court is concerned about the proposed Group Home on Jahn Court. New Concepts for Living is the company planning on building a Group Home for mentally disabled people in the near future on Jahn Court. He is concerned about the increased traffic, lighting and cameras that are planned to be used at the facility. He believes it is a business, exempt from taxes, being built within a Residential area and could decrease the Property Value of surrounding homes on the street.

Ms. Christine Ridlon of 120 Sherwood Avenue asked if anyone from the Township has spoken to the Principals of the Schools to get their thoughts of how the Cannabis Store would affect the schools and students.

Ms. Ridlon mentioned surrounding municipalities are also concerned about a Cannabis Store being introduced in Mahwah.

Mr. Erik Friis of 4 Sparrowbush Road, Upper Saddle River is also concerned about the Cannabis Store in Mahwah. He stated Upper Saddle River, Montvale, Saddle River, Allendale and Ramsey have all opted out of Cannabis. He is concerned the actions of one town will have an effect on other surrounding towns. He would like to see the Council vote No on the Cannabis Ordinance.

On a motion by Paz, seconded by Ervin, the Meeting was closed to the public at 8:20 PM. All in favor. Motion carried.

Mayor Wysocki stated he contacted a Representative at NJ Transit and will reach out to the Representative again. He indicated the Representative stated NJ Transit is aware of the situation.

May indicated the Council is considering all of the Residents' concerns regarding Cannabis.

Business Administrator will contact the Planning and Zoning Department on Friday, February 11 to review the information regarding the Group Home on Jahn Court.
