ORDINANCE NO. 1921**

AN ORDINANCE SETTING SALARIES FOR BLUE COLLAR EMPLOYEES

WHEREAS, the Township of Mahwah establishes salary ranges for all employee salaries, and

WHEREAS, the Township of Mahwah has approved a collective bargaining agreement for calendar years 2018 - 2021 with the UPSEU Blue Collar Unit, and

WHEREAS, the Township of Mahwah establishes salary adjustments for nonunion management employees in accordance with the related collective bargaining unit adjustments, and

NOW, THEREFORE BE IT RESOLVED, by the Township Council of the Township of Mahwah that the base salary ranges for blue collar employees (and associated management employees) for 2021 be as follows:


